#### SPACE ASSIGNMENT

---

#### INSTALLATION

---

The exhibit hall will be available for set-up from 6:00 am- 7:30 am on Monday, May 1, 2023. All exhibits must be set by 7:30 am without exception. Assembly of exhibits during exhibit hours will not be permitted.

#### CONDUCTING EXHIBITS

---

No drawing, raffles, or quiz-type contests of any type will be permitted. Electrical or other mechanical apparatus must be muffled so that noise does not interfere with other Exhibitors. Character of the exhibits is subject to the approval of the Societies. The right is reserved to refuse applications, which do not meet standards required or expected, as well as the right to curtail exhibits or parts of exhibits, which reflect against the character of the meeting. This applies to displays, literature, advertising, novelties, souvenirs, conduct of person, etc.

#### INFRINGEMENT

---

Interviews, demonstrations, and the distribution of literature or samples must be made within the area assigned to the exhibitor. Canvassing or distributing of advertising matter outside the exhibitor's own space will not be permitted.

#### FIRE PROTECTION

---

The Exhibitor, hired contractors, and others attending the R.O.C.K. Society Meeting must comply with all applicable federal, state and local fire and building codes as well as hotel rules and regulations, policies and procedures.

## **PROTECTION OF THE FACILITY**

---

Nothing shall be posted, nailed, or screwed, or otherwise attached to columns, walls, floors, or other parts of the convention center or its furniture. Distribution of promotional gummed stickers or labels is strictly prohibited. Anything in connection therewith necessary or proper for the protection of the building, equipment, or furniture will be at the expense of the exhibitor.

## **DISMANTLE**

---

Dismantle may occur no earlier than 12:00 pm on May 1<sup>th</sup>. All material must be removed from the facility no later than 1:20 pm.

## **INDEMNIFICATION**

---

Exhibitor, R.O.C.K. and the convention center shall mutually indemnify, hold harmless and defend each other, its officers, directors, employees, agents and members and bear all costs as they incur for all loss, expense, damage, cause of actions, claims or demands of whatever kind and nature, including judgements, interest and reasonable attorney's fees, which occur or arise directly or indirectly out of negligence, willful misconduct, breach of this Agreement by, or acts or omissions of each other's agents, employees, guests, or other third parties. Such indemnification of exhibitor, convention center and R.O.C.K. shall be effective unless such damage or injury results from the gross negligence or willful misconduct, breach of this Agreement by, or acts or omissions of each other's agents, servants, or employees in which case liability shall be apportioned between the parties according to each party's judicially determined liability. The right to indemnification depends on the party giving a written notice to the other within sixty (60) days of receipt of a written claim or demand.

## **INSURANCE**

---

Exhibitor and Hotel will maintain insurance sufficient to cover any claims or liabilities which may reasonably arise out of or relate to its obligations under this Agreement and will provide evidence of such insurance upon request.
